## **Directions to Our Office**

### **From Points North:**

Grand Central Pkwy or Northern State Pkwy to Meadowbrook Pkwy, *south*.  
Exit M-1, Old Country Road toward Westbury/Mineola.  
At stop sign at end of the ramp, turn right on Old Country Road, heading *west*.  
Follow directions below.

### **From Points South:**

Southern State Pkwy to Meadowbrook Pkwy, *north*.  
Exit M-1, Old Country Road toward Westbury/Mineola.  
At stop sign at end of the ramp, turn left on Old Country Road, heading *west*.  
Follow directions below.

### **From Meadowbrook Pkwy:**

Exit onto Old Country Road heading *west*.  
Travel approximately 1.2 miles (7 traffic lights).  
At 7<sup>th</sup> traffic light, turn left onto Lefferts Road (Mason & Mason Attorneys, green sign, is on the left). **IGNORE STREET NUMBERS ON THE RIGHT SIDE OF OLD COUNTRY ROAD.**  
Immediately after turning onto Lefferts Road, turn right into parking lot.  
*310 Old Country Road is accessible from the parking lot and is the last building in the lot. Our office is on the ground floor, Suite 101.*

### **Locally From Points West:**

Travel *east* on Old Country Road and pass Franklin Avenue.  
You will pass the County Court House on your right.  
Cross the intersection of Washington Avenue/Roslyn Road.  
**IGNORE STREET NUMBERS ON THE LEFT SIDE OF OLD COUNTRY ROAD.**  
Make the next right turn onto the small street between the office buildings called Ivy Court, which will bring you directly into the parking lot.  
Make a right turn behind the office building.  
*310 Old Country Road is the last building in the lot. Our office is on the ground floor, Suite 101.*

### **By Railroad:**

LIRR from Pennsylvania Station, Flatbush Avenue or Jamaica.  
Take train to Mineola station.  
It's a 10 minute walk to our office, or you can take a taxi.

#### To walk:

The elevated street that crosses above the train platform is Mineola Blvd.  
Walk to Mineola Blvd. and turn right to head *south*.  
At the first intersection (Old Country Road), turn left, heading *east*.  
You will walk past the County Court House on your right.  
At the 3<sup>rd</sup> traffic light, Washington Avenue, cross to the southeast corner.  
Our office is in the second building.
